#### NHTSA PRELIMINARY EVALUATION

The National Highway Traffic Safety Administration (NHTSA) has opened a preliminary evaluation of tire

valve stems cracking on certain 2007 model year Ford, Lincoln and Mercury vehicles. As always, Ford is cooperating completely with NHTSA on this evaluation. The following information should help Dealers answer any customer questions:

- Ford Motor Company has evaluated reports of cracked and/or leaking valve stems and has not identified a risk to motor vehicle safety on Ford vehicles.
- An importer of different valve stems has announced a safety recall, but this does not affect the valve stems installed as original equipment on Ford Motor Company vehicles.
- Ford valve stems may have the same generic industry standard "Type" numbers with similar markings or symbols as other valve stems. Ford valve stems are manufactured with a different material formulation, to different performance specifications, and on different equipment than these other valve stems.

#### TIRE VALVE STEM WARRANTY COVERAGE

As a reminder, tire valve stems are covered under the existing new vehicle Bumper to Bumper Warranty (3year/36,000 miles Ford & Mercury, 4year/50,000 miles Lincoln) for defects in materials and workmanship.
